

Tradition





1978 created a PPO Labudnjaca, and the composition of PPO Labudnjaca are entered: KBI Bac (with all Economies I, II, III, IV, feed mixers, livestock and fish pond), PD Labudnjaca from Vajska (with the economy alive, Labudnjača Stapar and dehydrator), Subcontractors from Bac with work unit Zadrugar and Worker, ZZ Selenca (with the cooperation and community sector) and Mlinpek Bac (now the mill and silos).

The same year, the PIK Bac separated into: OUR Brotherhood (today's farming and cattle breeding) and OUR Pond.

1982, set aside the cooperation and formed a special cooperation: ZZ Lowlands Plavna and Backo Novo Selo, Cooperation and Bac, Cooperation ZZ Selenca.

And joining the OUR Mlinpek OUR Worker and OUR Brotherhood and produced PPK Agrobacka Bac.

PPK Agrobacka with all parts lasted until 1990 until it was dissolved Labudnjaca.

Since 1982 to 1990 Agrobacka is build the silos, spread poultry and made incubator.


1998 introduced temporary measures to consolidate the company.
