

In accordance with Article 38 of the Law on Privatization ("Official Gazette of the RS", nos. 38/01, 18/03 45/05,123/2007 and 123/2007 other laws), and Article 9 of the Decree on sale of capital and property by Public auction ("Official Gazette of the RS" nos. 52/05 91/07 and 960/08),
the Privatization Agency announces:

PUBLIC INVITATION FOR PARTICIPATION IN PUBLIC AUCTIONS

Basic data on Auction sale

Interested parties can purchase the auction documents at the price of **RSD 40000**, after they receive the invoice from the Privatization Agency. VAT is not calculated in the price. Purchase of the auction documents is obligatory, and on their receipt one is to sign the Confidentiality Agreement. After the payment evidence has been submitted, the auction documents can be collected at the following address:

The following entities have the right to participate in the Public Auction:

A) Domestic or foreign legal entity which cumulatively fulfils the following requirements:

- 1. It is registered for performing business related to activity group 55 – motels and restaurants,**
- 2. It achieved total annual operating revenues of minimum (based on the data from the financial statement for 2007) 2.000.000,00 EUR in the last business year,**
- 3. It owns a hotel which is categorized as a four–star hotel, which shall be proved by the Ruling on Catering Trade Facility Categorization issued by the Ministry of Economy and Regional Development in accordance with the provisions of the Law on Tourism («Official Gazette of the Republic of Serbia» no. 45/05), i.e. by the Ruling on Categorization issued by the competent body of the state in which a potential auction participant is registered.**

The legal entity shall be deemed to fulfil the necessary requirements for participation in the auction if it owns more than 50% of the capital of the legal entity which cumulatively fulfils the requirements for participation in the public auction.

B) Domestic or foreign individual

1. which owns more than 50% of the capital of the legal entity which cumulatively fulfils the requirements referring to legal entities for participation in the public auction.

C) Consortium – the consortium shall be deemed to fulfil the necessary requirements from this Public Invitation if the consortium members meeting the requirements have at least 51% of the entire stake in the consortium.

DEADLINE FOR SUBMISSION OF APPLICATIONS IS 19.03.2009 AT 16:30

Filled application, which is a part of the auction documents, with the signed draft of the SPA and the deposit payment evidence, is to be submitted in a sealed envelope marked with: "THE APPLICATION FOR PARTICIPATION IN PUBLIC AUCTION 270309, Privatization Agency, Belgrade, 23 Terazije St, 5th floor".

IF THERE IS THE NAME OF THE ENTITY UNDERGOING PRIVATIZATION ON THE ENVELOPE, OR FULL AUCTION CODE, THE APPLICATION CAN BE REJECTED.

Means of payment can be in domestic currency, foreign convertible currency, state bonds based on the unpaid foreign currency savings, which are due not later than the date of the capital sale (27.03.2009.) issued to the individuals, who are citizens of the Republic of Serbia. If the participant applies only for the second bidding, the means of payment can be even the state bonds based on the unpaid foreign currency savings, which are not due until the date of the capital sale (27.02.2009.) issued to the individuals, who are citizens of the Republic of Serbia.

In case that the first class bank guarantee has been submitted as the means of deposit payment, it is to be due within 48 hours after the declaration a buyer.

Deposit for participation is to be returned 21 days after the Public auction has been held.

The Privatization Agency keeps the right to change the auction date, as well as the deadline for the application submission if necessary, but also to inform the interested parties on such changes, if any, until the auction date at the latest.

The site visit shall be carried out after signing the Confidentiality Agreement in the period from 12.02.2009 to 18.03.2009.
