

In accordance with Articles 20a and 30, and in connection with Article 34 of the Law on Amendments and Supplements to the Privatization Law («Official Gazette RS», no. 45/05 and 123/07), as at November 10, 2008, the Privatization Agency announces:

**INVITATION FOR
SUBMISSION OF CLAIMS**

1. The Privatization Agency (hereinafter: Agency) invites public companies, Tax Administration, Republic Pension and Disability Persons Fund, Republic Health Insurance Fund, Republic Commodity Reserves Directorate, the Development Fund of the Republic of Serbia, other republic bodies and organizations, as well as Deposit Insurance Agency when it conducts duties of a bankruptcy administrator in the banks in bankruptcy, and when it administers, on behalf of and for the account of the Republic of Serbia, the claims of the Republic of Serbia based on assumed foreign liabilities (hereinafter: the State Creditor), to submit their claims as at December 31, 2004, against the following entities undergoing privatization, i.e:
2. The State Creditor is obliged to submit its claims against the entity undergoing privatization referred to in the Clause 1 of this Invitation, within 15 days after the date of announcing this Invitation in the daily «Politika».
