Public Invitation for participation in the Public bidding for purchasing the real estate and equipment of the Hotel and tourist complex Inex Zlatna obala, Sutomore, sale code IZO 050509, published on March 19, 2009 in the daily newspaper «Politika», has been changed in the part that relates to: period for site visits, submission of Bid Bond/deposit payment, submission of Application for participation in the public bidding and Public bidding date, pursuant to the following:

1. Clause 2 has been changed so that it reads as follows:  
**Initial selling price** of the property being sold is **EUR 17,000,000,00 (seventeen million euros)** and it is divided in the following way:
  - **for the property from the Item A Construction facilities** amounting to EUR 16.011.453,00 and the Buyer can pay it in six annual installments, in accordance with the provisions of the Decree on Amendments to the Decree on Procedure and Method of Restructuring of the Privatization Entity (Official Gazette of the RoS no. 96/08) and Sale Documents, and
  - **for the property from the Item B Equipment, small inventory and supplies**, it amounts to EUR 988.547,00.
2. Clause 3 paragraph 2 of the Public invitation has been changed as follows:  
The Agency hereby invites all interested parties to submit a written request for purchase of the Sale Documents and deliver the payment evidence, at the latest until **September 4, 2009 at 4:30 p.m.**
3. Deadline for site visit of the Subject of sale, deadline for submission of the Bid Bond/deposit payment, deadline for submission of applications for participation in the public bidding and public bidding date have been changed as follows:
  1. Participants may visit the subject of sale until **September 11, 2009.**
  2. Participants in the procedure are obliged to submit the Bid Bond amounting to EUR 3,400,000.00 (three million four hundred thousand euros) or to pay the deposit to the same amount, at the latest until **September 18, 2009.**
  3. Deadline for submission of applications for participation in the public bidding is **September 18, 2009 at 4:30 p.m.**
  4. The public bidding will be held on **September 22, 2009 at 11:00 a.m.** Belgrade time, at the following address: Privatization Agency, Terazije 23, 2nd floor, Large hall, Belgrade.
