#### 1. Subject of Sale

#### 3. Opening Price & Sale Conditions

Opening price for the Subject of Sale at the public bidding is set in the amount of 6,450,226 EUR (six million four hundred and fifty thousand two hundred and twenty six euros).

Obligations of the buyer of the Subject of Sale are established by the Sale and Purchase Agreement, which is an integral part of the Sale Documents.

The buyer is committed to continue to employ all full-time employees employed by the Seller at the time of this sale process, according to the list provided as integral part of the Sale Documents, as provided by the Sale and Purchase Agreement.

The buyer is committed to start up production of mineral fertilizers within the period of one year after the signing of the Sale and Purchase Agreement, as well as keep the production continuity in the following period of at least two years, as specified in the Sale and Purchase Agreement.

By submitting the application for participation in public bidding, Participant agrees to the terms specified in the Instructions for Participants and the Sale and Purchase Agreement, which are integral part of the Sale Documents.

# 4. Eligibility

Participation at the public bidding is open to any domestic or foreign legal entity or individual that has:

- a) Purchased the Sale Documents,
- b) Paid Deposit or submitted the Bid Bond for participating in the public bidding and
- c) Submitted the application for participating in the public bidding;

Consortium which consists of legal entities and/or individuals ("Consortium") that fulfils the above stated conditions also has the right to participate in the public bidding. One of the Consortium members, i.e. the person authorized by the Consortium, has to be appointed as Consortium representative ("Authorized representative of the Consortium") and to act in the name and for the account of the Consortium.

Buyer of the immovable property cannot be: 1) a domestic legal entity which operates with majority socially-owned capital; 2) a legal entity and individual that has due, but unsettled liabilities toward the Seller, 3) subsidiaries of the Seller, and 4) a person who was convicted or against whom proceedings have been brought for criminal offences defined by Article 12 of the Law on Privatization («RS Official Gazette» no. 38/2001, 18/2003, 45/2005 and 123/2007). Such applications shall be rejected without consideration.

Any individual or legal entity, with the limitations given in Instructions for Participants, has the right to participate in the public bidding provided that it has purchased the Sale Documents, submitted the application for participation in the public bidding and paid the Deposit in the amount of: 650,000 EUR (six hundred and fifty thousand euros), or submitted the first-class bank guarantee (Bid Bond) in the same amount according to the Instructions to Participants.

In case the Bid Bond is submitted for payment of the Deposit, it must be payable within 48 hours after proclamation of the buyer at the public bidding.

Participant in the procedure is obliged to pay Deposit in the amount specified in clause 4 for the subject of sale of its interest, or to submit Bid Bond in the same amount, not later than February 11, 2009.

## 5. Due Diligence Procedure

Upon signing the Confidentiality Agreement and purchasing Sale Documents, i.e. in the period from January 12, 2009 to February 11, 2009, Participant shall be allowed to visit the assets representing the subject of sale, meet with authorized personnel and inspect financial, commercial and legal information relating to the assets.

## 6. Application for Participating in the Public Bidding

If the envelope should bare the name of the sale subject or the full sale code, the, application will be rejected. Application for participating in the public bidding is filled on a special form, which is a part of the Sale Documents, and must contain data requested in the Instructions to Participants, evidence of payment of the deposit and number of the account for the return of the deposit. Incomplete and untimely applications will not be taken into consideration. Sale Process Commission will inform all applicants at least two working days prior to the public bidding if their applications were approved.

#### 7. Public Bidding

Public bidding will be held on February 20, 2009, at 14.00 hours Belgrade time, at the following address: Privatization Agency, Terazije. 23, 2nd Floor, Belgrade. Registration of public bidding participants will be held at the same address, on February 20, 2009, from 13.00 to 13:50 hours.

Deposit will be returned to all participants that are not proclaimed as buyers within the time period specified in the Instructions to Participants.
